RIGGER LEVEL 1

Class time: 4 Hours Maximum Students - 10

This program illustrates the proper use and pre-use inspection of rigging gear, slings, and below-the-hook lifting devices to ensure those who complete training are competent. The student will receive the necessary instruction to properly perform pre-use rigging gear inspections; perform proper rigging selection and techniques; and rig basic shapes.

Note: this class can be combined with the Signaller program for total class time of 8 hours.

SIGNALPERSON QUALIFICATION

Class time: 4 Hours Maximum Students - 10

This program includes the technical training, testing, and practical examination necessary to become a qualified signal person. The student will learn and understand the type of signals used at the worksite; become competent at using these signals; and understand the operations and limitations of the equipment, including the crane dynamics involved in swinging, raising, lowering and stopping loads and in boom deflection from hoisting loads.

Note: this class can be combined with the Rigger Level 1 program for total class time of 8 hours.

AERIAL / SCISSOR LIFT OPERATOR

Class time: 4 Hours Maximum Students - 10

This program provides the necessary information to perform the required daily pre-use inspection, identify potential hazards that could result in personnel injury and/or equipment damage, and safely operate aerial/scissor lifts. The student will be given a written exam and will be required to satisfactorily perform a practical examination.

POWERED INDUSTRIAL TRUCK OR TELEHANDLER OPERATOR

Class time: 4 Hours Maximum Students - 10

This program provides the necessary information to perform the required daily pre-use inspection, identify potential hazards that could result in personnel injury and/or equipment damage, and safely operate powered industrial trucks and/or telehandler. The student will be given a written exam and will be required to satisfactorily perform a practical examination.

OVERHEAD CRANE & HOIST OPERATOR TRAINING

Class time: 8 Hours Maximum Students - 10

This program provides the technical training, testing, and practical examination necessary to become a qualified overhead crane/hoist operator. The student will receive the proper instruction to perform the required daily pre-use inspection, identify potential hazards that could result in personnel injury and/or equipment damage, and safely operate overhead cranes and hoists. The student will be given a written exam and will be required to satisfactorily perform a practical examination.

OVERHEAD CRANE & HOIST FREQUENT INSPECTION

Class time: 4 Hours Maximum Students - 10

This program provides the necessary technical information and instruction to become qualified to perform *frequent* overhead crane/hoist inspections. The student will be able to perform the required frequent inspection, identify potential hazards that would hinder the safe operation of overhead cranes and hoists, and know what documentation must be retained to keep a program in compliance.

BOB'S RIGGING AND CRANE HANDBOOK and/or BOB'S OVERHEAD CRANE & RIGGING HANDBOOK CAN BE PROVIDED UPON REQUEST.

Course durations are approximate due to student participation, skill levels, and quantity.

Students will be issued certificates of completion and wallet cards upon successful completion.
